Happy Holidays to Everyone. What a wonderful time of the year. Please take time to wish Happy Holidays to all residents as you run into them. That little gesture can mean a lot. Our next board of directors meeting is on December 1st in the Clubhouse. The meeting is open to all HOA members and will start at 6:30PM. Now is the opportunity to mention any concerns you have about what's happening in our park. It's also a chance to meet new board members and learn their plans to improve the park. We will be able to go over the questions that were brought up to management last month and discuss their answers. I do know that a huge issue is the phone directory. Management put out a questionnaire about three months ago that was to be returned by all residents who wanted to be in the directory. Only 144 people responded to the questionnaire. Since the response was so low, no directory was printed. There were many reasons that the response was low. A lot of people told us that they never saw the questionnaire or that they did not realize what it was because it was lengthy. We requested the office to provide a brief sheet with three or four questions for us. This will be done by this week and can be picked up at the office or requested online. The form MUST be returned no later than the 15th of December in order to be included in the new directory which will be produced in January. PLEASE make this a priority so that we can get a directory as soon as possible. We also have been told that the sprinkler system is totally repaired, and all should be working at this time. If your sprinklers are not working, you must put in a new work order and they will be looked at individually. Previous work orders will not apply. Another item that I would like to bring up is the lights on the pickle ball / tennis courts and the shuffle ball courts. If you are playing shuffle ball, please do not turn on the lights for the pickle ball courts, only turn on those that are needed. I also see all the lights on when no one is playing in any of the areas – is there a reason for this or is it just because someone wants to waste electricity? Remember, put equipment back when you have finished using it so it will be available for everyone when needed. Your board is here for you so let us know if we can help you. As of November 20<sup>th</sup>, we did receive a proposed counter from Cove and are working with them to HOPEFULLY have a signed contract soon. We can't say anything at this point as details still need to be worked out and until CONTRACT IS SIGNED BY COVE AND NEGOTIATING TEAM. Please do not spread rumors that we have a CONTRACT. #### OVERNIGHT CARAMEL PECAN FRENCH TOAST

2 cups brown sugar 12-14 thick slices French Bread (3/4" thick)

2 TBLS light corn syrup 1 cup milk 12 TBLS butter 6 eggs 2/3 cup heavy whipping cream pinch of salt

2 teaspoons vanilla 1 teaspoon cinnamon

1 ½ cup pecans; chopped

Grease 9" x 13" pan. Over low heat, combine the brown sugar, light corn syrup, butter and whipping cream in a medium saucepan. Keeping the heat on low; DO NOT let it boil! Stir constantly until the butter is melted and the ingredients are smooth. Remove from heat and add ½ teaspoon of the vanilla. Pour the warm caramel mixture in the 9 x 13 pan. Sprinkle the pecans over the top. In a large bowl, beat together the milk, eggs, salt, the other ½ teaspoon vanilla and cinnamon. Dip the bread into the egg mixture, making sure each piece is well coated. You want to soak up the mixture with your bread. Lay the bread in the pan, over the caramel and pecan mixture. Cover and refrigerate overnight. In the morning, preheat oven to 425 degrees, remove cover from the pan and bake for 20 minutes, until the bottom is bubbling and the toast is golden brown. Let stand a couple of minutes, then invert on platter. Eat right away. 12 servings
